# Job description

## Responsible to

Headteacher

You will be required to carry out the duties of a Academy teacher as set out in the current Academy Teachers' Pay and Conditions Document. In addition to the duties above you will be required to demonstrate the leadership skills specified in the National Standards for Subject Leaders and to undertake the following responsibilities in relation to the post:

#### **Generic responsibilities:**

- To undertake an appropriate programme of teaching in accordance with the duties of a standard scale teacher.
- To ensure provision of an appropriately broad, balanced, relevant and differentiated curriculum for students studying in the curriculum area, in accordance with the aims of the Academy and the curricular policies determined by the Governing Body and Headteacher of the Academy.
- To act as a Curriculum Lead and be responsible for leading and developing this area.
- To develop and enhance the teaching practice of others.
- To monitor and support the overall progress and development of students as a manager within the curriculum area and as a Form Tutor.
- To play a full part in the life of the Academy community, to support its distinctive mission and ethos and to encourage staff and students to follow this example.

# **Strategic:**

- To coordinate the delivery of the Creative Arts subject curriculum, resources, schemes of work, marking policies, assessment and teaching strategies in the department.
- The day-to-day management, control and operation of the curriculum provision within the department.
- To monitor and follow up student progress.
- To implement Academy Policies and Procedures.
- To work with colleagues to formulate aims and objectives for the department which have coherence and relevance to the needs of students and to the aims and objectives of the Academy.



- To ensure that the planning activities of the department reflect the needs of the students and the aims and objectives of the Academy.
- To manage the application of ICT in the Curriculum area.

#### **Curriculum:**

- To ensure the delivery of an appropriate, comprehensive, high quality and costeffective curriculum programme which complements the Academy's strategic objectives.
- To keep up to date with national developments in the subject areas and teaching practice and methodology.
- To actively monitor and respond to curriculum development and initiatives at national, regional and local levels.
- To maintain accreditation with the relevant examination and validating bodies.
- To explore opportunities for appropriate extra-curricular and community activities within the department.

#### **Staffing:**

- To work with SLT to ensure that staff development needs are identified and that appropriate programmes are designed to meet such needs.
- To contribute to Performance Management and to act as reviewer of staff within the designated department.
- To promote teamwork and to motivate staff to ensure effective working relations.
- To ensure the effective efficient deployment of classroom support.
- To participate in the Academy's ITT programme.

# **Quality management:**

- To ensure the effective operation of quality control systems.
- To set targets within the department and to work towards their achievement.
- To establish common standards of practice within the departments and develop the effectiveness of teaching and learning styles in all relevant curriculum areas within the departments.
- To contribute to the Academy procedures for lesson observation.
- To implement Academy quality procedures and to ensure adherence to those within the departments.
- To participate in the monitoring and evaluation of the curriculum area/departments in line with agreed Academy procedures including evaluation against quality standards and performance criteria.
- To implement modification and improvement where required within the relevant curriculum areas.
- To ensure the maintenance of accurate and up-to-date information concerning the relevant curriculum area on the management information system.
- To produce reports within the quality assurance cycle.
- To identify appropriate courses and coordinate examentries within the department.

# **Pastoral support:**

 To monitor and support the overall progress and development of students within the curriculum areas



- To monitor students' progress ensuring that follow-up procedures are adhered to and that appropriate action is taken where necessary.
- To act as Form Tutor and carry out the duties associated with the role as outlined in the generic job description.
- To contribute to SMSC according to the Academy policy.
- To implement the Behaviour Management system in the department so that effective learning can take place.

## Other specific duties:

- To support the Academy in meeting its legal requirements for worship.
- To promote actively the Academy's corporate policies.
- To continue personal development as agreed.
- To promote and manage liaison with feeder Primary Schools/ Partner Schools in relation to Creative and Performing Arts
- To undertake any other duty as specified by STPCB not mentioned in the above.
